( ) **Corresponding Member** holds a license to practice as an APN or PA by their respective country or is a registered nurse who holds at least a Masters degree, has been in continuous practice at the same facility for at least one year devoting at least 50% of their professional time to pediatric orthopaedics, practices outside North America: Annual Renewal \$ **90.00**
